  - (a) The issue of inclusion vs. Exclusion
  - (b) The history of the Hall of Flags/Hall of Nations as an antiquated 18<sup>th</sup> Century concept
  - (c) The lack of safe spaces on campus
  - (d) Identity and the importance of representation to students/staff/faculty
  - (e) The origins of the hall and reasons for its existence, etc.
