## 3. Leadership Development Inquiry

Eric Hoffman, Associate Dean for Center for Teaching and Learning and Oswald Fraser, Executive Director of Human Resources discussed their findings and recommendations from the Leadership Development Inquiry report. They stated that the assessment of the ECP-level personal, team and systemic leadership development needs were based on responses to a short set of questions in an anonymous, online survey from 21 members of the Leadership Team and comments in a dozen group or one on one conversations with all team members in the six divisions outside of the President's Office. President Mellow thanked both Eric and Oswald for their hard work.
