- I. Campus/CUNY Updates:** President Adams informed the Cabinet that he has appointed Nayelli Valencia Turrent to serve as his Chief of Staff beginning on 11/1/21. He has requested Cabinet members to meet with Ms. Turrent as part of her onboarding process.
- II. Review 9/20/21 Cabinet Meeting Notes:** Notes reviewed and no changes noted.
- III. Enrollment**
 - a. Weekly Enrollment Update: Associate Dean Baksh-Jarrett discussed the weekly enrollment chart (attached).
- IV. Fall 2021 Return to Campus**
 - a. Implementation of Student Vaccination Requirements: The Cabinet discussed implementation of vaccination requirements and identified the need to enhance communication to students through social media, texting and email. In addition, the Provost will develop communications to faculty and staff regarding the vaccination requirements for students attending in-person/hybrid classes in Fall 2021. The Cabinet discussed situations in which students are partially vaccinated and whether flexibility can be given to students to allow them to avoid imposition of an Administrative Withdrawal (“WA”) grade. The Cabinet recognized that the college’s decisions will need to be informed by CUNY Central Office policy and protocols. Continued

discussion about the implementation will continue and the Cabinet acknowledged the need to ensure all students entering campus are vaccinated, while seeking to limit the number of students impacted by the WA grade.

- b. Proof of Vaccine Verification for Entering Campus: The Cabinet discussed the policy that LaGuardia community members can enter campus by either displaying the CUNY Vax Pass through the personal Cleared4 link or your LaGuardia Mobile App I.D. with green border.
