IV. Senate Meeting Updates

- The April 10th Senate Meeting was attended by Alexandra Rojas, ASC Chair. The Senate wanted a report of the ASC Committee activities.
- James Grantham was present at the Senate meeting and he provided information on the new Emergency Response Guide. Meeting attendees raised the concern that this information should be made more accessible to students. The ASC committee was asked if they knew about the Emergency Response Guide – the majority replied they did not know about it. The ASC committee members discussed that there should be some mention of the Emergency Response Guide in the syllabus or to have professors at least mention where the emergency exits are located at the beginning of the first class; however, all agreed more consideration should be taken on how and when to communicate what should be done in the event of an emergency. The committee agreed to invite James Grantham to the next ASC committee meeting to address general concerns that were raised during the meeting.
- Credit for Life Experience was discussed at the Senate meeting. It was mentioned that the college should issue credit for life experience to students. A question was raised if this was any different from "Credit for Prior Learning" which has always been a student service at the college that was managed by Professors Janice M. Karlen and Susan M. Sanchirico. Alexandra Rojas will confirm for the committee who the contacts for the Credit for Life Experience are.

V. Web Page

VI. C Grade Policy

The ASC Committee is seeking additional information on the practice of allowing students to retake courses in which a letter grade of a "C" is earned. The goal is to bring the policy (that is stated in the course catalog) to practice. The committee is waiting for the Senate to follow up with the committee as to whether they want us to make changes.

VII. Other topics

- a) Registrar is piloting new scheduling software that will assist students with creating their course schedules. Rollout is expected by next spring 2020.
- b) The following question was raised: Are students admitted to LaGuardia with degrees required to participate in First Year Seminar? The answer provided: The course will show up as a requirement, but it can be waived.
