

Preamble

WHEREAS, LaGuardia Community College is dedicated to the development of its students,

WHEREAS, the goals of the college are to provide access and opportunities for a diverse and talented student body and foster growth in wisdom, creativity, self-confidence, autonomy, global awareness and humanity,

WHEREAS, the Student Government Association at LaGuardia is integral to the achievement of student success and the goals, allowing students to grow in service to others as leaders, decisions-makers, as fiscal stewards, and to display virtues such as a respect for rights and liberties, a sense of responsibility, a capacity for empathy and judgment, and commitment to the principles of democratic self-government,

WHEREAS, these principles are enshrined in this constitution and need to be actively pursued by all present and future members of student government,

LET IT BE RESOLVED THAT, The Student Government Association establishes this Constitution to represent students in the functioning of the college, to exercise our right to propose measures that are designed to better student life and represent student concerns, and to promote the academic, social and cultural welfare of students.

Article I

Powers and duties of the SGA

1. The name of the organization shall be the LaGuardia Community College Student Government Association. Hereby known as the "SGA".
2. The SGA shall consist of thirteen (13) student governors elected by the LaGuardia student body.
3. Among the thirteen (13) governors, five (5) will serve as Executive Officers (President, Vice President, Secretary, Treasurer, and Event and Program Coordinator) and constitute the Executive board, seven (7) will serve as Academic Representatives, and one (1) will serve as the Parliamentarian.
4. The purpose of the SGA is to
 - (a) represent the LaGuardia student body and act as its primary voice and representative to the College Administration, the faculty, other student organizations, the other members of the College community, CUNY and its constituent parts, the general public;
 - (b) increase student interest in participation in educational, social, and cultural affairs at the college;
 - (c) promote academic freedom and the rights of the students;
 - (d) inform itself on college programs by seeking information from the College on all matters germane to those operations of the College that impact student success;
 - (e) and generally, promote student welfare.
5. In order to meet its obligations as the primary representative of the student body, SGA takes responsibility for;
 - (a) informing students about availability of campus services and the action that the SGA has taken to improve the welfare of the students;
 - (b) helping to promote social and cultural programs and events on campus, supporting student clubs and ethnic organizations;
 - (c) maintaining fiscal integrity, high ethical standards in its own operations, enriching the academic life of the college;
 - (d) assisting international students with their particular problems;
 - (e) raising political awareness by bringing political debates and events to campus and advocating for LaGuardia through contact with government officials and Public Advocates.

6. To efficiently and adequately serve the changing needs of the student body, SGA shall collectively plan two programs and/or events that address relevant need.

In order to achieve its purpose and meet its obligations, SGA is empowered to create and amend bylaws for its own internal operations, consistent with this constitution and with the policies and bylaws of the LaGuardia Community College and CUNY board of Trustees.

Article II

Election of the Governors

1. The election of the Governors is organized by the Students Elections Review Committee (SERC). Governors are elected during the month of April or May, take office on July 1 and serve for one (1) year. Governors may be re-elected for one additional term. No governor shall serve more than two terms. Candidates for the Governors receive an orientation introducing them to the rules and procedures established by SERC that govern campaign and election. A copy of the SERC rules and procedures shall be available in the Office of Campus Life and the Office of the SGA. It is the responsibility of candidates to know the rules for campaigning established by SERC; candidates may be barred from the SGA office by SERC for violating the rules.
2. All candidates for Governor and those serving as Governors must be enrolled - after the official deadline for withdrawal has passed - for minimum of 6 credits. Additionally, to be eligible to run for the office or serve in the office, students must also be up-to-date with payments of tuition and fees, be in good academic standing, and maintain a minimum cumulative GPA of 2.5 for a position as Governor, a minimum cumulative GPA of 3.0 for a position on the Executive Board and a minimum cumulative GPA of 3.2 for the offices of Vice President and President. Moreover, a student must have completed and earned a passing grade in at least 50% of the credits for which the student was registered after the official deadline for withdrawal in the prior semester. All the candidates must be committed to serve their full term. Failure to comply with this regulation will result in immediate removal from the Government by the SGA Governors and Administration.
3. No students shall run for or hold any elected position in any executive position in clubs or in the Student Senate.
4. SERC is responsible for the conduct of elections. SERC is authorized to organize the election and, if it desires, may hire an outside firm to run the elections. All matriculated students are eligible to vote. Each student can cast one (1) vote for each of the Executive positions (President, Vice President, Treasurer, Secretary, Event and Program Coordinator), one (1) vote for Parliamentarian and one (1) vote for their specific Academic representative (Business and Technology, Education and Language Acquisition, Social Science, Health Sciences, Humanities, STEM, Liberal Arts and English).
5. Governors are elected based on results from the Spring elections. During the election process, candidates can run for one position only; Executive position or Parliamentarian or Academic representative (Business and Technology, Education and Language Acquisition,

Social Science, Health Sciences, Humanities, STEM, Liberal Arts and English). Academic representatives are based on the academic major of the candidate. A candidate may not run for an Academic representative position outside of the candidates major.

6. The candidate with the most votes in each of the thirteen (13) elected position will become the student representative for that position.
7. In the event of a vacancy in the office of the SGA President, the Vice President becomes President. In the event of a vacancy in any other Executive Officers position, the members of the Executive Board select a replacement from among all of the governors; a majority of the Executive Board (i.e. 3 votes) is required to fill such a vacancy. In the event of a vacancy in a governor position that is not part of the Executive Board, SGA will review all eligible candidates from the election ballot. This process will remain in effect for 6 months after the official start date of the SGA. If eligible candidates are not found on the list, then replacement will be sought from all matriculated students; the majority of the governor votes (i.e., 7 votes) is required to fill such a vacancy with the consent of the mentor(s).
8. Official Governor positions (Public Relations, Club and Ethnic Affairs, Academic Affairs, Political Awareness, Sustainability/ Part-time and Evening Affairs, Students with Disabilities, and International Students and Foreign Affairs) will be assigned prior to the start of the term through internal elections.

Article III

Duties of the Executive Officers

1. **The President** of the SGA shall

- (a) serve as Chief Executive Officer of the SGA and its Executive Board, assume primary responsibility for the fulfillment of the SGA duties and purposes;
- (b) prepare the agenda for all SGA and Executive Board meetings and must distribute the agenda to all members of the appropriate body by email at least three (3) days before the meeting is to take place, as well as the announcing the meeting in a manner that satisfies the requirements of the open meeting law;
- (c) preside at all SGA meetings and meetings of the Executive Board;
- (d) appoints the members and chairs of all SGA standing and ad-hoc committees and serves as ex-officio member of all committees except as otherwise described in the Constitution;
- (e) maintain proper and orderly procedures at all meetings with the assistance of the Parliamentarian and mentor(s);
- (f) receive the monthly reports from the other governors;
- (g) be the principle representative and spokesperson for the SGA and its constituents to LaGuardia students, faculty and administration, and to the general public (or may designate another governor to speak on behalf of the SGA);
- (h) be a signatory for College Association checks;
- (i) establish and presents long-, medium-, and short-term goals to the SGA;
- (j) vote last on every procedure or proposal;
- (k) strategically propose and plan events and programs for the SGA to sponsor with the assistance of the Program and Events Coordinator;
- (l) serve as the second delegate to the University Student Senate (USS);
- (m) be a member of the College Senate, the Auxiliary Enterprise board, President's cabinet, the College Association, and Technology Fee Committee, as well as chairing the College Association Budget Committee.

2. **The Vice President** of the SGA shall

- (a) preside in the absence of the President;
- (b) serve as the principal liaison between the SGA committees and Executive board;
- (c) be a signatory on College Association checks when the President is unavailable;
- (d) be responsible for chairing the Campus Improvement Association (C.I.A.) Committee with students and Governors;
- (e) serve as one of the Directors of the Auxiliary Enterprises board.

3. The Secretary of the SGA shall

- (a) produce all minutes and recordings of SGA and Executive Board meetings (if absent, arranges for another Governor to take the minutes and shall be responsible for those minutes to be distributed to all Governors as well);
- (b) post minutes on the SGA website, and sends copies to the SGA archives in the campus library;
- (c) prepare correspondence on behalf of the SGA or Executive Board;
- (d) maintain a file of all correspondence to and from the SGA, and shares all correspondence with the Governors;
- (e) keep track of the SGA attendance and budget requests.

4. The Treasurer of the SGA shall

- (a) keep accounts of all SGA receipts and expenditures;
- (b) prepare and present a bi-weekly written budget report at general SGA meetings, and must distribute to all members of SGA by email at least three (3) days before general SGA meeting;
- (c) hold a weekly meeting with Events and Program Coordinator to prepare and process purchase orders for all SGA-sponsored events;
- (d) receive bills and prepare check requests so that SGA bills will be paid;
- (e) process stipends for all Governors;
- (f) be responsible for preparing all the purchase requisition on behalf of SGA;
- (g) serve as a member of College Association Budget Committee and the board of directors of College Association.

5. Event and Program Coordinator of the SGA shall

- (a) manage and coordinate all SGA Programs and Events in conjunction with Governors;
- (b) compile and present a draft of the complete social calendar for SGA approval and update as needed;
- (c) establish plans and execute SGA signature programs and events (or may designate another governor as needed), including but not limited to: Welcome Week, Voter Registration, SGA Ambassador, Town hall.
- (d) attend in the absence of the Treasurer at the College Association Budget Committee.

Article IV

Duties of the Academic Representatives

Each of the Academic representatives is expected to serve as the primary advocate for the academic majors associated to their Academy. Academic representatives serve as the liaisons between students in their academy and the divisions of Academic Affairs, and Student Affairs.

The Academic Representatives of SGA shall

- (a) represent and advocate for students of their academy;
- (b) be responsible for informing students of all changes, updates, and available services for students of their academy;
- (c) be responsible for supporting and enriching the academic life of students of their academy;
- (d) attend monthly meeting with Governor of Academic Affairs;
- (e) be the liaison between students and academic administrators, faculty and staff;
- (f) maintain communication with their academic chair(s), program director(s), academic advisor(s), and other appropriate bodies;
- (g) attend SGA Townhall meetings and all meetings and events related to their academy;
- (h) be members of SGA Academic Affair committee.

Article V

Duties of the Governors

In addition to their primary responsibility as Academic representative, the seven (7) student Governors who are not the Parliamentarian or members of the Executive Board will each assume a leadership role in one specific area of the SGA responsibility. These positions will be assigned prior to the start of the term through internal elections.

1. **The Governor of Public Relations** of SGA shall

- (a) be responsible for informing students about the availability of campus services and the actions that the SGA has taken to improve the welfare of students;
- (b) be responsible for maintaining all tools of communication including but not limited to social media accounts the SGA may use;
- (c) be responsible for heading and designing all promotional efforts of SGA programs and events in conjunction with the Events and Program Coordinator;
- (d) keep the SGA bulletin boards up to date;
- (e) work closely with College Marketing Department and submit SGA accomplishments to the College website and Student Information Center (SIC) (i.e. Student News and Emails);
- (f) serve as the member of the board of directors of College Association.

2. **The Governor of Club and Ethnic Affairs** of SGA shall

- (a) be responsible for supporting clubs and ethnic organizations and functioning as a liaison to these organizations;
- (b) serve as the principal liaison between the SGA and Student Advisory Council (SAC);
- (c) attend SAC meeting if there is no concurrent SGA meeting;
- (d) receive weekly minutes of SAC meeting;
- (e) serve as one of the members of College Association Budget Committee and member of the board of directors of College Association.

3. **The Governor of Academic Affairs** of SGA shall

- (a) be responsible for enriching the academic life of the College;
- (b) work with all the academic services including the academic advising, tutoring, testing lab, admissions office;
- (c) be responsible to meet with the Vice President of Academic Affairs every month which will be included in the monthly report;
- (d) be responsible to support and maintain communication with Academic Representatives;
- (e) preside at the monthly meeting with Academic Representatives;

- (f) be responsible for chairing the SGA Academic Affairs Committee;
- (g) serve as one of the members of the Board of Directors of College Association.

4. The Governor of Political Awareness of SGA shall

- (a) be responsible for raising political awareness among students by bringing political debates and events to campus;
- (b) be responsible to organize at least two political events per semester;
- (c) maintain good communication with the Government Relations and Community Engagement liaisons on campus;
- (d) serve as the first Delegate to the University Student Senate;
- (e) be responsible to provide a Constitution to every Governor;
- (f) be a member of Constitution committee if there is need to update the Constitution;
- (g) be responsible for chairing the SGA External Affairs committee;
- (h) serve as one of the voting members of the Tech-fee committee.

5. The Governor of Sustainability/ Part-time & Evening Affairs of SGA shall

- (a) represent and advocate for part-time and evening students;
- (b) be responsible for informing students of available services for part-time and evening students;
- (c) be responsible for maintaining an open relation with part time and evening students;
- (d) serve as the Vice Chair of C.I.A., and leading member of the Sustainability Council;
- (e) serve as one of the members of the board of directors of College Association, Director of Auxiliary Enterprises board and voting member of the Tech fee committee.

6. The Governor of Students with Disabilities of SGA shall

- (a) be an advocate for students with disabilities;
- (b) work with the office for Students with Disabilities to improve the LaGuardia experience;
- (c) serve as one of the official delegates for the CUNY Coalition for Students with Disabilities (CCSD) representing LaGuardia community. Must attend all meetings which do not cause conflict with the SGA meetings or events;
- (d) be a member of C.I.A. Committee, finds ways to improve campus to become more accessible for students with disabilities;
- (e) work closely with on-campus clubs related to students with disabilities;
- (f) put together events/workshops for students with disabilities;
- (g) serve as one of the embers of Auxiliary Enterprises board.

7. The Governor of International Students & Foreign Affairs of SGA shall

- (a) be an advocate on behalf of international students;
- (b) work closely with Governor of Political Awareness to organize at least two immigration awareness events each year;
- (c) work with Office for International Students to address the issue of students and improve the quality of learning;
- (d) update SGA and LaGuardia community on Foreign Affairs;
- (e) work closely with Governor of Public Relations to provide scholarship information to the students;
- (f) serve as the chair of the SGA Scholarship committee;
- (g) serve as one of the members at the College Association board of Directors.

Article VI

Duties of the Parliamentarian

The Parliamentarian of SGA shall:

- (a) attend all SGA general meetings, special meetings, emergency meetings, and executive board meetings;
- (b) maintain proper and orderly procedures during all meetings by assuring that members follow the SGA Constitution, Bylaws and Robert's Rules of order;
- (c) serve as non-voting member of SGA, only to vote in case of a tie;
- (d) remain as impartial, neutral, and unbiased figure;
- (e) have the right to veto in public (and in writing) on any matter voted upon by the SGA within five (5) school days of said action. This veto may be overridden only by a unanimous vote of the SGA and must take place within ten school days following the veto;
- (f) arrange for another Governor to serve temporarily as parliamentarian if forced to be absent from a meeting. This Governor shall retain the right to vote as a Governor and only obtain the right to maintain proper and orderly meeting procedure;
- (g) allow a faculty or staff mentor to provide assistance to the Parliamentarian and SGA Governors if procedural tangles prevent a meeting from doing business;
- (h) be the first individual to receive allegations of impeachable acts against a Governor;
- (i) be mandated to receive a formal training prior to taking office. Failure to complete this mandate within 30 days after taking office will result in a suspension. Mentor(s) will be responsible to arrange training for the SGA Parliamentarian;
- (j) be responsible to meet with each Governor every month and give a monthly Parliamentarian's report including concerns of the Governors;
- (k) serve as one of the Directors of Auxiliary Enterprises board.

(I) Article VII**University Student Senate – USS**

The University Student Senate, hereby known as USS, is an official and recognized governing body of CUNY. USS is a body held with the responsibility to accurately and adequately serve and advocate for the needs of over 500,000 students in over 25 CUNY campuses.

1. The Governor of Political Awareness of SGA shall serve as first delegate of USS
2. The President of SGA shall serve as second delegate of USS.
3. Two USS alternate delegates shall be elected by the majority of SGA body; if no one wishes to run for said position, the SGA President shall delegate the roles to the remaining Governors.
4. USS Delegates and Alternates shall
 - (a) attend all USS meetings and USS-related events of importance to SGA;
 - (b) provide a Delegate Report along with monthly report;
 - (c) prior to each USS meeting, be provided with a directive by the SGA in anticipation of, and to be presented at that meeting of the USS;
 - (d) following the USS meeting, relate all communication from the USS meeting to the SGA at the next SGA general meeting.

Article VIII

The Conduct of Meetings

1. All meetings are open to all members of the College community.
2. As long as it is done in an unobtrusive manner, any person present may record the meeting pending the chair's approval.
3. All votes are openly declared and public (i.e., either by roll call or show of hands). Each Governor's vote must be recorded in the minutes. No member may vote in absentia (i.e., members must be physically present in order to vote).
4. Except if otherwise provided in this Constitution or the SGA bylaws, the conduct of meetings will follow Robert's Rules of Order.
5. The majority of the Governors (i.e., 7) and the majority of the Executive Board (3) constitute a quorum. Without a quorum, no official business may proceed.
6. To pass a resolution at the SGA meeting, a majority of all Governors (3 of the 5 Executive Officers) must vote for it.
7. All governors are expected to attend all regular and special meetings of the SGA. As explained in the SGA bylaws, the college pays governors a modest stipend based upon their attendance and performance; part of the stipend is forfeited when governors are absent from SGA meetings or fail to deliver their reports. All governors will remain available one day in a week for SGA meetings and events upon the President's request. The request must be sent 15 days before the semester starts.
8. All governors are expected to be present for all meetings, faithfully attend to their duties, cooperate with each other, and present themselves in a professional manner particularly in situations where they represent the SGA and LaGuardia student body before campus, CUNY, and community audiences. Governors are automatically excluded from the SGA if they miss more than four meetings

Article IX

Mentoring of the SGA

1. The Student Government Association is hereby overseen by the Division of Student Affairs. The mentor(s) shall be a member from the Division of Student Affairs, appointed by the Vice President for Student Affairs and serving as the primary mentor to the SGA, fulfilling the duties and mentorship that is required by the SGA bylaws.
2. Mentor(s) shall be responsible to read the Constitution and bylaws during the first SGA meeting in front of every new SGA member and make the new Government familiar with all the rules and regulations of the campus.

Article X

SGA Standing Committees

All SGA governors shall serve in at least two (2) standing committees, unless directed otherwise by the SGA President. All matriculated students shall be eligible to serve on any SGA Standing Committees with the exception of College Association Budget Committee.

There shall be six standing committees of the Student Government:

1. College Association Budget Committee
 - (a) Responsible for accepting and reviewing proposals that request financial support from the Student Fees by faculty/staff/and clubs.
 - (b) The President is responsible to chair this committee.
2. Campus Improvement Association
 - (a) To serve, encourage and recommend to the administrators at LaGuardia on issues that affect the student.
 - (b) The Vice President is responsible to chair this committee.
3. Scholarship Committee
 - (a) Responsible for collecting scholarship information, developing new scholarships and raising funds for the scholarships (i. e. Giving Day).
 - (b) Governor of International Students and Foreign Affairs is responsible to chair this committee.
4. Academic Affairs Committee
 - (a) Responsible for identifying and formulating solutions to problems of admission, academic advising, tutoring, testing and other academic related problems faced by students.
 - (b) This committee shall consist of all Academic Representatives. The Governor of Academic Affairs is responsible to chair this committee
5. External Affairs Committee
 - (a) Responsible for informing students of issues outside of the college campus including all university, local, state, and national matters.
 - (b) This committee shall consist of all USS delegates and alternates.
 - (c) The Governor of Political Awareness is responsible to chair this committee.
6. Student Life Committee
 - (a) Responsible for informing and advocating of student life issues including but not limiting to health, food insecurity, recreation, housing, transportation, and safety.
 - (b) The Governor of Public Relation is responsible to chair this committee.

Each SGA Standing Committee shall

- (a) hold a committee meeting at least once a month, which is open to the College community;
- (b) assign committee vice chair and committee secretary during the first meeting through internal elections;
- (c) report to the SGA of their meetings and activities twice each semester.

Article XI

Impeachment

1. Governors are subject to impeachment if they:
 - (a) accumulate 4 or more unexcused absences during their year of service;
 - (c) tamper with SGA elections;
 - (d) offer improper inducements to influence SGA actions;
 - (e) are significantly derelict in their duties;
 - (f) engage in conduct that violates the rules of the New York State Board of Education that governs the College.

Impeachable offenses that violate rules include committing theft, causing willful and significant damage to College property, employing or intentionally provoking violence, engaging in indecent or highly disruptive conduct, possessing weapons, possessing or using illegal drugs, unlawfully possessing or using alcohol, significantly interfering with the education of others, engaging in sexual misconduct, employing hate speech, and engaging in criminal acts.

2. Any allegation regarding impeachable acts shall be communicated by the Parliamentarian to the SGA mentor(s). The SGA mentor(s) will form an Impeachment Panel, consisting of the members of the Faculty-Student Disciplinary Committee (FSDC) and three Governors: Parliamentarian (or Vice President if the Student Faculty Disciplinary Committee finds that the Parliamentarian is not judged to be a neutral figure), another member of the Executive Board, and a Governor who is not a member of the Executive Board. The Student Faculty Disciplinary Committee is charged with selecting the Governors for the Impeachment Panel who appear to be the most neutral in terms of the specific allegation(s) and personalities involved. The Impeachment Panel conducts a confidential preliminary investigation. The Panel may choose to question Governors or others having knowledge regarding the allegation.
3. The Impeachment Panel has two major decisions to make. Decisions are made on the basis of a majority vote (50%+ 1).
 - (a) Based on its preliminary investigation, the Panel has the final authority to decide whether an allegation rises to the level of an impeachable offense. The Impeachment Panel may either decide that:
 - a. there are sufficient grounds for an Impeachment process to continue, or
 - b. there are insufficient grounds for Impeachment.

- (b) If the Impeachment Panel finds sufficient grounds for the process to continue, after a period of no less than two weeks from the time of that decision, the Panel will meet publicly in a special session to consider expelling a Governor through the process of impeachment. The Panel will consider the allegation, hear witnesses, and weigh the evidence. The Impeachment Panel designates one of its members to chair the session, establish an orderly atmosphere, and protect the rights and reputations of all parties. At the conclusion of the special session, the Panel votes on whether to expel the Governor through impeachment. Any Governor who is impeached is not eligible to run for election to any student office at the College. An impeached individual is still subject to other disciplinary actions by the College.

Article XII

Recognition of Other Governing Bodies

Subject to CUNY bylaws and New York State higher education law, the Student Government Association is an organization that respects the roles of the Executive Council, College Senate, Faculty Council, and University Student Senate in the Governance of the College.

The SGA also recognizes and respects the roles of those subordinate student organizations - clubs and the Student Advisory Council - that are formed to reflect areas of student interest, identity, and social activity.

The subordinate student organizations function and operate independently follow their governance policies. These governance policies shall not contradict SGA Constitution. Any amendments of these governance policies must be approved by the SGA prior to the implementation.

Article XIII**SGA Bylaws**

1. Through bylaws, the SGA may regulate its own internal affairs, but not establish substantive policies. Bylaws may not contradict the SGA Constitution. The SGA may adopt bylaws at any regular meeting by majority vote (i.e., 7 of the 12 Governors), provided that the wording of the proposed bylaw(s) or amendment to an existing bylaw(s) has been placed on the agenda and that Governors have received a minimum of three (3) days' notice of the meeting and its agenda.

2. Bylaws are an appropriate place for the SGA to place any rules regarding the conditions under which stipends for Governors are provided, as well as rules regarding the proper conduct of Governors at meeting.

Article XIV**Amending the Constitution**

The SGA Constitution may be amended by a vote of 2/3 of the Governors at two general meetings of the SGA, and after approval by the Vice President of Student Affairs and the President of the College. For meetings that are to vote on an amendment to the SGA Constitution, the wording of the proposed amendment must be placed on the agenda and the Governors must receive a minimum of three (3) days' notice of the meeting and its agenda.
