Dear LaGuardia faculty and staff—

It's great that the Fall Semester has begun in earnest, and that there is noticeably more activity in our hallways and around campus. Here's the latest:

**Student Vaccination Deadline:** As a reminder, students enrolled in hybrid or in-person courses must upload proof of vaccination to CUNYfirst by September 27. Unvaccinated students in these courses must obtain the single-dose Johnson & Johnson vaccine by tomorrow, September 23, to comply with the CUNY-required timeline.

Between September 27 and October 7 our Health Services Center will continue to complete document verification for students. A plan is now being developed to engage and advise students that do not have vaccination documents uploaded by the deadline. Process for how faculty and advisors can best work with the unvaccinated students to maintain academic progress will be shared next week.

**Access to Campus with Cleared4:** Everbridge will be completely phased out this weekend. Beginning Monday, September 27 only the CUNY Access Pass via Cleared4 will be accepted to enter campus. Instructions for vaccinated individuals to set up the CUNY Access Pass are found [here](#). Unvaccinated faculty and staff participating in weekly testing will continue to utilize the Cleared4 Test Result.

Please note that Cleared4 does not utilize a traditional smartphone app that is downloaded; rather you will need to open your personalized link each time you access campus to display a dated Pass. You may want to bookmark your personal link in your phone's browser or home screen, or paste the link into a note to find easily. If you have questions how to do this ask a colleague or student. They'll certainly be able to assist.

**Reporting Positive Cases:** As a reminder, all individuals who have tested positive for COVID-19 or have any [symptoms of Coronavirus](#) should stay home, self-isolate, and immediately notify the *College Coronavirus Designees* using the applicable email:
