#### Overview of findings, analysis, recommendations and future initiatives

#### **Objective 1.1**

#### Results

- 100% of the calls were efficiently routed. 88.6% of incidents and/or calls reported to Public Safety were rerouted to appropriate College Departments for resolution, e.g., Building and Grounds, Student Affairs, Housekeeping, Environmental Health & Safety, Human Resources, Title 9, etc.
- The remaining 11.4% were resolved by Public Safety, kept open pending additional investigation or kept on file for informational purposes.

#### **Analysis**

- Public Safety followed up all incidents to ensure their resolution. Since incident resolution can take months
  depending on type of incident, Public Safety kept some cases open for long periods of time until they were
  resolved.
- Largest single category of incidents was medically related internal and external incidents (36%).
- Externally (NYPD, FDNY, etc.) rerouted and internal LaGuardia departments representing a broad range of categories with at least 20 incidents rerouted totaled 42.3% of all incidents rerouted.

#### Recommendations and future initiatives

 Public Safety will continue to route 100% of incidents to correct departments or to outside resources, i.e., NYPD, FDNY, etc.

#### Objective 1.2

#### **Results**

- Public Safety started initiative to identify preventative measures to deter and reduce number of incidents beginning with Building & Grounds.
- Efforts resulted in a decrease from 10.1% to 7.4%, achieving the target of 2% reduction.

#### **Analysis**

• From a Public Safety standpoint, the campus was secure. Although incidents increased during the first six months of 2023 (337) compared to the first six months of 2022 (218) by 54.6% due to the increase in campus occupancy, 2023 should not be compared to 2022 data or other years with any significance attached due to the extreme changes caused by the pandemic.

- Continue to identify preventative measures to deter and reduce number of incidents with highest numbers routed, i.e., SA, SJO (Student Judicial Officer), Title IX Coordinator.
- Since the pandemic has passed and LaGuardia has achieved a "new normal", incident report data collected and reviewed for LaGuardia's fiscal year 7/1/22 6/30/23 will serve as the benchmark for annual incident reports going forward.

#### Results

- 2.1) Successfully increased video storage capacity from 90 days to 120 days, exceeding the 100 day minimum target.
- 2.2) Increased number of cameras from 525 to 530, an increase of 1%, which is less than the 4% target.

#### **Analysis**

• Purchase of new server provided increase in storage capacity and enhanced Public Safety's ability to look back and resolve crimes and other serious incidents.

#### **Recommendations and future initiatives**

Continue to monitor vulnerable areas and add cameras as necessary to increase video storage capacity.

## Overall summary

#### Goal 1: Improve campus awareness and preparedness to maintain a safe campus.

Public Safety continued to focus on maintaining a safe and secure campus to help support building student access and success, and an inclusive community.

With a sustained increase in the number of faculty, staff and students coming to campus, Public Safety continued to assign greater priority to ensuring incidents were efficiently routed to the correct internal and external departments. 100% of the calls were efficiently routed. 88.6% of incidents and/or calls reported to Public Safety were rerouted to appropriate College Departments for resolution, e.g., Building and Grounds, Student Affairs, Housekeeping, Environmental Health & Safety, Human Resources, Title 9, etc. The remaining 11.4% were resolved by Public Safety, kept open pending additional investigation or kept on file for informational purposes.

To help ensure a safe campus environment, Public Safety successfully increased video storage capacity from 90 days to 120 days, exceeding the 100 day minimum target. The purchase of a new server provided the increase in storage capacity and enhanced Public Safety's ability to look back and resolve crimes and other serious incidents.

Public Safety increased the number of cameras from 525 to 530, an increase of 1% which was lower than the 4% target.

#### Moving forward:

- Considering the number of cameras now on campus, Public Safety will evaluate if continuing to use a specific percentage increase in the number of cameras is a valid target.
- Public Safety will continue to expand its ability to review past incidents in order to resolve crimes and other serious incidents by continuing to monitor vulnerable areas and adding cameras as necessary.
