I. Call to Order

The meeting was called to order at 2:26PM by Chairperson Cristy Bruns.

II. Approval of Agenda

The agenda was approved without corrections.

III. Approval of the Minutes from March 12, 2025

The minutes were approved with minor corrections. The College Association and Faculty Student Disciplinary Committee elections are upcoming and were incorrectly described as completed. The University Faculty Senate's letter on academic freedom was incorrectly described as a resolution.

IV. Approval of Curriculum Committee Consent Calendar Items from March 13, 2025

A motion to approve the Curriculum Committee consent calendar items from March 13, 2025 was made by Senator Streich. This was seconded by Senator Ildefonso-Sanchez. **Vote: Aye-27, Nay-0, Abstain-1**. The Curriculum Committee consent calendar items from March 13, 2025 were approved.

V. Presentation from Senate's Budget and Finance Committee – Introduction to LaGuardia's Budget

The Senate's Budget and Finance Committee presented an introduction to the LaGuardia's budget including the college's budget and financial structure, tax levy funding, the CUNY and LaGuardia allocation processes, and the PSC travel budget. The presentation is available on the Senate's website.

VI. Chair's Report

The final revised Governance Plan was submitted to President Adams. The document will also need to be approved by General Counsel and Senior Vice Chancellor for the Office of Legal Affairs Derek Davis and the CUNY Board of Trustees. LaGuardia's Executive Legal Counsel to the President Maria Cook emphasized the importance of providing a redlined version of the document.

At the March 12th meeting, the LaGuardia Senate voted to sign on to the University Faculty Senate's letter on academic freedom that condemned Governor Hochul's request to remove a Hunter College job posting for a position in Palestinian Studies. Thirteen CUNY colleges made statements against Governor Hochul's actions by signing the UFS letter and/or drafting their own. The job opening was reposted with new language.

Two faculty members are needed to serve on the College Association, the body that allocates student activity fee money. In accordance with the CUNY bylaws, governance will choose a panel of candidates from which President Adams will select two to join the College Association. VP Alexis McLean suggested that the Senate serve as the governance body electing the panel of candidates, but as the positions are for faculty, Faculty Council may be a more appropriate governance body to oversee the process. More discussion will follow as to which governing body will take on the role.

Once the change is approved by New York State, the CUNY Office Assistant exam will no longer be used in the hiring process.

HR Director Mary DiGangi is planning to create a more uniform onboarding orientation. President Adams wants to ensure that Senate is a part of the process.

International students should be instructed to contact International Student Services if they plan to travel abroad to get advice on travel restrictions/advisories and to complete necessary paperwork.

VII. Invitation to President's Chief of Staff Nayelli Valencia Turrent for Presentation on the 29th Street Greenway Project

The 29th Street Greenway Project seeking to transform 29th Street into an outdoor plaza is firmly underway. With the support of Council Member Julie Won, LaGuardia applied for support through the LIC Downtown Revitalization Initiative, is collaborating with LIC Partnership to explore new programming opportunities, and is partnering with the Department of Transportation to launch the plaza design process. The LaGuardia Community Greenway Mural Contest is accepting applications through May 19, 2025. Activating the plaza for public use is scheduled for June-July 2025. LaGuardia will be responsible for basic maintenance tasks.

VIII. Invitation to President Kenneth Adams

In light of Director of LaGuardia Performing Arts Center (LPAC) Steven Hitt's retirement, LaGuardia is using the opportunity to examine LPAC's role at the college. In previous years, LPAC operated at a financial deficit. In 2024, LPAC brought in \$500,000 and cost \$900,000 to operate, yielding a \$400,000 loss. LaGuardia brought in a consultant who reached the following conclusions:

- (1) LPAC is not used as much as it could be. LPAC should host productions and presentations from outside institutions in addition to performances produced by members of the LaGuardia community. Its proximity to Manhattan and its accessibility via the subway make it an attractive option for performances, workshops, and rehearsals.
- (2) LPAC conditions need improvements (lighting, sound, etc.) to be attractive to potential renters which will require capital funding.
- (3) Faculty members should be able to utilize the LPAC facilities more easily. The college needs to improve communication with LPAC staff and prioritize facility use by college members.

President Adams agreed that LPAC should serve the larger community, but not at the expense of its faculty, staff, and students. It has the potential to generate revenue while providing experiences for members of the LaGuardia campus. LaGuardia is beginning a search for a new Director of LPAC to accomplish these goals.

President Adams was selected to participate in the Aspen Institute's Presidents Fellowship, "a year-long executive leadership program for 25 community college presidents who want to advance social mobility and talent development in their communities by improving student outcomes." He is looking forward to learning from the fellowship's curriculum and his fellow participants.
